1.0 Ucapan Aluan Presiden merangkap Pengerusi AGM

Pengerusi mengucapkan tahniah kepada Prof. Dr. D Kamarudin D Mudin iaitu Penasihat PERDESA atas lantikan sebagai Timbalan Naib Canselor UMS dan Dr. Freddie Robinson iaitu Timbalan Presiden PERDESA atas lantikan sebagai Pengarah Pusat Rawatan Warga. Presiden mempelawa lebih ramai ahli menyertai PERDESA disebabkan visi dan misi adalah selaras dengan objektif universiti.

Pengerusi mengulas aktiviti sepanjang tahun yang berjaya dilaksanakan oleh PERDESA. Namun rancangan menjalankan aktiviti kesihatan bersama JKNS di Pulau Bangi, Kudat pada minggu ini terpaksa dibatalkan atas sebab ketiadaan sumber air.

6.2.1 Clause 4 (1.2)

“This category of membership is open to all Ordinary Members on payment of a specific fee fixed at the AGM and subject to approval by the Registry of Societies Malaysia.”

“This category of membership is open to all Ordinary Members on payment of a specific fee fixed at the AGM, upon approval of executive committee. A life membership applicant should have at least been an ordinary member for one year.”

6.3 Clause 5 Resignation and Termination

6.3.1 To remove Clause 5 (1)

~~The member does not have qualifications necessary to become a member of the Society as mentioned in section 4 of this Constitution.~~

6.3.2 *Clause 5 (3)*

Any Member who has defaulted on his or her membership fees for more than two years shall be notified so by a reminder signed by the Secretary or his representative and on further continuation of the default, the member shall lose his/her benefits of membership until such time the debt is remedied and an application for restoration is made.

Any Member who has defaulted on his or her membership fees for more than two years shall be notified so by a reminder signed by the Secretary or his representative and on further continuation of the default, the member shall lose his/her benefits of membership until ~~he/she resumed his/her membership such time the debt is remedied and an application for restoration is made.~~

6.4 Clause 6 Source of Income

6.4.1 Clause 6 (1)

The life membership fees will be RM500.00. It can be paid as single payment or installment within a year.

Supportive members are required to pay RM10.00 of registration fees.

6.4.2 Clause 6 (2)

The subscription fees shall be paid to the Treasurer at the time of application for membership and subsequently, it is to be paid on 1st of January each year. ~~The membership fees for the first year shall only cover the months on that year. The membership fees would only cover that calendar year.~~

6.4.3 Addition of Clause 6 (6)

A life member shall be an ordinary member in good standing when applying for life membership. He/she may pay for the entire life membership fee in one calendar year, subject to approval by the executive committee.

6.5 Clause 7 General Meeting

6.5.1 Clause 7 (4)

The Secretary must send to every member of the Society, at least 14 days before the date of the AGM, the agenda of the meeting together with a copy of the announcement, annual reports, and duly audited statement of account for the previous year. A copy of the letter announcing the AGM must also be posted at the registered address of the Society.

6.8.2 Clause 10 (4)

“... cannot be incurred without the prior approval of the executive committee and the expenses which is more than RM 10 000 (Ringgit Malaysia Ten Thousand) at any one time ...”

“... cannot be incurred without the prior approval of the executive committee and the expenses which is more than RM 50 000 (Ringgit Malaysia Fifty Thousand) at any one time ...”

“... can be approved by the Honorary President together ...”

6.9 Clause 15 Prohibition

6.9.1 Addition of Clause 15 (5)

All logos and representative symbols of the society shall not be used by anyone without a written approval from the executive committee. The society reserved the right to take legal action against those who violated this law.


